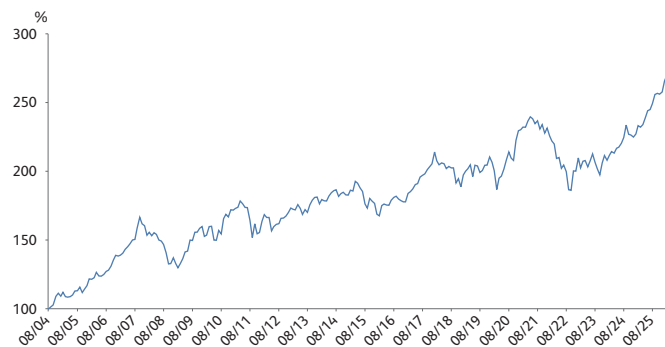

Manager’s Comment 基金經理評論

Global equities regained their upward trajectory in April, notching another historic high as geopolitical headwinds subsided. A temporary ceasefire in the Middle East provided a critical window of relief, catalyzing a strong recovery in equity prices.

Global bond markets extended their sell-off in April, driven by mounting concerns over an energy shock following the closure of the Strait of Hormuz.
