Under normal circumstances, the investment choice is expected to invest a substantial portion of its assets in global bonds with exposure to the currencies of the United States, Europe and other countries; and the balance in global equities, including but not limited to equities listed or quoted in the United States, Europe, Japan, Hong Kong and other major Asian markets. The investment choice may also invest in other types of investments, including, but not limited to money market instruments.

### Manager’s Comment 基金經理評論

Global equities regained their upward trajectory in April, notching another historic high as geopolitical headwinds subsided. A temporary ceasefire in the Middle East provided a critical window of relief, catalyzing a strong recovery in equity prices.

Global bond markets extended their sell-off in April, driven by mounting concerns over an energy shock following the closure of the Strait of Hormuz.
