Terms and Conditions

1. This premium discount on **Evergreen Growth Saver Plus II** (the “Premium Discount”) promotion (the “Promotion”) is offered by Prudential Hong Kong Limited (“Prudential” or “we”) and covers the period from 30 March to 26 June 2021, both dates inclusive (the “Promotion Period”).
2. The Promotion is applicable to the policies applied through the Agency channel or Broker channel of Prudential.
3. In order to be eligible for the Premium Discount under the Promotion,
 - (i) customers must have successfully applied for and submitted the completed application of **Evergreen Growth Saver Plus II** (with a single premium payment term and HKD or USD as the policy currency) (the “Selected Plan”) to us within the Promotion Period;
 - (ii) Selected Plan must have been issued by us on or before 31 July 2021;
 - (iii) the single premium amount of each Selected Plan must meet the amount listed in the 1st page; and
 - (iv) the discounted amount will be directly deducted from the single premium amount and customers only need to pay for the premium balance and levy.Selected Plan will be eligible for the Premium Discount (the “Eligible Plan”) if the Selected Plan meets all applicable requirements as set out in clause 3. Otherwise, the Premium Discount will be forfeited.
4. In case the single premium payment is rejected by the bank, the Premium Discount will be forfeited.
5. In the event of the Eligible Plan is cancelled during cooling-off period, we will return you the actual premium and levy you paid in the payment currency.
6. The Premium Discount is offered to each Eligible Plan. If a customer has successfully applied for more than 1 Eligible Plan during the Promotion Period and fulfilled all other requirements stated under these terms and conditions, each Eligible Plan will be qualified for the Premium Discount.
7. The Promotion will not be offered to the Selected Plan applied for or in force on or before 29 March 2021, or to any other basic plan(s) or supplementary benefit(s), or to any policy conversion.
8. The Single Premium is calculated in HKD. For USD policies, the exchange rate of USD 1 to HKD 7.8 is applied to determine the Single Premium after existing premium discount equivalent in HKD.
9. We will calculate the Premium Discount amount based on each Eligible Plan’s Single Premium excluding levy.
10. The Premium Discount is non-transferable to others or other policies and cannot be exchanged or redeemed for cash even when the policy is surrendered, matured or lapsed.
11. The Premium Discount under the Promotion will form part of the policy contract upon the respective policy and/or the respective supplementary benefit (if applicable) being issued if the requirements of the Premium Discount under the terms and conditions of the Promotion are satisfactorily fulfilled.
