Terms and Conditions

1. The premium discount on the **Prime Vantage Prestige Protector Insurance Plan** (the “Premium Discount”) promotion (the “Promotion”) is offered by Prudential Hong Kong Limited (“Prudential” or “we”) and covers the period from 9 to 31 December 2025, both dates inclusive (the “Promotion Period”).
2. The Promotion is applicable to the policies applied for through the Agency channel or Broker channel (if applicable) of Prudential.
3. In order to be eligible for the Premium Discount under the Promotion,
 - (i) customers (i.e. policyholders) must have successfully applied for and submitted the completed application for the **Prime Vantage Prestige Protector Insurance Plan** (the “Selected Plan”) within the Promotion Period;

7. The Promotion will not be offered to any other basic plan(s) or supplementary benefit(s), or to any policy conversion or plan migration (if applicable).

9. We will calculate the Premium Discount amount based on each Eligible Plan’s sum assured.
