Terms and Conditions

- 1. myPrudential "Self-Service Policy Change Application" Promotion Campaign (the "Promotion") is offered by Prudential Hong Kong Limited ("Prudential") and covers the promotion period from March 1 to April 30, 2024, both dates inclusive (the "Promotion Period").
- 2. During the promotional period, policyowners who successfully submit the qualified self-service policy change application for their life insurance policies through myPrudential will automatically receive one chance into the lucky draw for each successful application submission, with no limit on the number of chances.
- 3. Qualified self-service policy change applications for the life insurance policies include setting up autopay via bank account, updating contact information or payment mode, and appointing beneficiary. The policyowners must successfully submit the relevant application on myPrudential during the Promotional period.
- 4. For setting up autopay via bank account, the life insurance policies must be inforce (single premium policies and fully paid-up policies are excluded) and without setting up any valid autopay bank account before 1 March 2023. In order to be eligible for the lucky draw chance, the autopay setup self-service policy change application submission at myPrudential must be made within the Promotion Period for making renewal premium payment.
- 5. For updating contact information or payment mode and appointing beneficiary, the life insurance policies must be inforce and the self-service policy change application submission at myPrudential must be made within the Promotion Period in order to be eligible for the lucky draw chance.



- 6. If policyowners or his/her/their financial consultant have submitted paper application or other means of eapplication for the same self-service policy change application, the application will not be eligible for the lucky draw chance. Prudential's system record shall prevail.
