All units allocated under your PRUlink capital investment plan are notional and solely for the purpose of determining the account value of your policy. You are NOT investing directly in the reference funds of the investment choices. You do not have any rights or ownership over these reference funds.

The reference fund is an equity fund which aims to provide investors with long-term capital growth through investment mainly in the listed equities and equity related securities (including warrants and convertible securities) of companies whose activities are closely related to the economic development and growth of the economy of the People's Republic of China ("PRC"). Cash and debt securities may be considered when appropriate.

The reference fund may employ a portion of its assets in futures contracts, options or forward currency transactions for the purposes of efficient portfolio management and hedging against exchange rate risk.

The reference funds of BOCHK China Consumption Growth Fund, BOCIP China Value Fund, Schroder International Selection Fund – Hong Kong Dollar Bond and Schroder International Selection Fund – Hong Kong Equity may use derivatives for hedging and/or investment purposes. The reference funds of other investment choices may use derivatives for efficient portfolio management and hedging purposes only. Derivatives may be more sensitive to changes in economic or market conditions and could increase the volatility or exposure of the reference funds of investment choices to losses that exceed the cost of the derivatives. General Notes

Closure of Investment Choices

In case of termination, merger, closure for subscription or switching-in of any investment choices, Prudential will give no less than 1 month's prior notice or such shorter period of notice in compliance with the relevant regulatory requirement(s).

Valuation

The base currency of each investment choice is Hong Kong Dollar.

The valuation date of an investment choice is the same as the valuation date of its respective reference fund which is determined by the relevant manager of the reference fund.

In circumstances such as closure, restriction or suspension of trading on any securities market in which the reference fund of the investment choice is invested or in any exceptional circumstances (including but not limited to any inevitable interruption of Prudential's normal business, typhoon, breakdown of means of communication and military events) which are beyond the control of Prudential that such suspension or deferment is necessary, Prudential shall have the right to suspend or defer the valuation, creation and cancellation of units of any investment choices.

Forward pricing is adopted. That means the unit price of investment choices are not yet determined when the order of the units is placed, but will be based on the unit prices at the close of the trading day.

The unit issue price and unit redemption price of each investment choice on a valuation date will be the same as the quoted unit issue price and unit redemption price of that reference fund on the valuation date and in the currency of that reference fund. Currently, the quoted unit issue price and unit redemption price of the reference funds of all investment choices will be displayed in not more than 4 decimal places. For those quoted unit issue price and unit redemption price of the reference funds displayed in less than 4 decimal places, the corresponding unit issue price and unit redemption price of the investment choices will be displayed in 4 decimal places by placing zero(s) after the last number of the price of the respective reference funds.

The number of issued units of investment choice will be determined by dividing the subscription amount by the unit issue price and it will be rounded to the nearest 4 decimal places. In case of change of the current practices, Prudential will give no less than 1 month's prior notice or such shorter period of notice in compliance with the relevant regulatory requirement(s).

Unit price of investment choices will be published in the South China Morning Post, the Hong Kong Economic Times and Prudential's corporate website.

Dividend

If there are dividends declared and payable in respect of the reference funds, Prudential may at its sole and absolute discretion by reference to dividend payment method of the share class of the corresponding reference fund:

- (i) to re-invest the relevant amount back into that investment choice so that such dividend amount will be reflected in the unit price of the investment choice; or
- (ii) to distribute the relevant dividend amount by issuing additional units of that investment choice and allocate such units into the policy account of the policy while the policy is in force; or
- (iii) to pay the dividend to you by cheque, or by other means (including but not limited to direct credit the dividend amount to your designated Hong Kong Dollar bank account in Hong Kong) as Prudential may decide while the policy is in force.

Taxation

Taxation consequences of investing in **PRU**link capital investment plan depend on the applicable tax laws of your particular situation. You are recommended to seek independent professional advice about your relevant tax consequences.
