- Self-inflicted injury or illness
- Alcoholism or drug abuse
- Any known conditions or any illness disease infirmity physical defect or condition which existed or known prior to the receipt date of application of the Policy
- For trip not originating from Hong Kong
- For trip relocating to Mainland Ching or Macau
- Pre-existing medical conditions
- Venereal disease, AIDS or AIDS related complex
