Investment Objective 投資目標

PRUlink China Equity Fund (investment choice) will be invested in BOCHK Investment Funds - BOCHK China Equity Fund (Reference Fund). The Reference Fund is an equity fund which aims to provide investors with long-term capital growth through investment mainly in the listed equities and equity related securities (including warrants and convertible securities) of companies whose activities are closely related to the economic development and growth of the economy of the People's Republic of China. Cash and debt securities may be considered when appropriate. The Reference Fund may employ a portion of its assets in futures contracts, options or forward currency transactions for the purposes of efficient portfolio management and hedging against exchange rate risk.
