Manager's Comment 基金經理評論

Global bond markets retreated in May. Bond weakness was led by Japan and the U.K., amid fiscal policy concerns and shifting investors sentiment. Global equities closed in the positive territory despite a shallow pullback late in the month. The rebound from last month's rout continued, fueled by stronger-than-expected earnings from mega-cap technology stocks and the easing of US-China trade tensions following Geneva talks.
